An active member is a person who disseminates to the public and receives remuneration for the news, information or thoughts concerning the outdoors and/or the use, management and enjoyment of natural resources. Such dissemination can be in any of the following fields: writing for publication, editing, broadcasting or telecasting, illustration (including photography), or public speaking. An active member shall have full voting privileges and the right to hold office.

New student member (\$10 per year or \$11 PayPal)

A person who subscribes to the purpose and standards of this organization, but who, at the time of application, is not eligible for active membership. Such membership shall remain in force until he/she qualifies for active membership. Student members shall be accorded all privileges of membership except the right to vote and the right to hold office.

New supporting member (\$100 per year or \$105 PayPal)

Any individual, organization, association, business or commercial firm which has a common interest in the purpose of this Association and desires to contribute to the accomplishment of such purposes. Such members may be admitted to membership upon approval by the Board of Directors and upon payment of dues. Supporting members shall not have the right to vote or the right to hold office; however, supporting members are represented through an ex-officio position on the Board of Directors.
